## General notes regarding examination fees:

- The examination fees tabled below are charged to candidates via their chosen BOHS training provider. The training provider will also charge a training fee for delivering the course.
- There is a minimum charge of four candidates per invigilated sitting, and we will invoice for the number of exam papers ordered.
- Cancellation fee: A cancellation fee, equivalent to the fee for one candidate, will be charged, if exam papers have been dispatched before a course has been cancelled.

New training provider application, assessment and registration fee: £795 Please note there is an additional £300 materials inspection fee per module.

**Assignment re-submission fee**: £40 (for report and case study modules, a candidate is allowed one free re-submission. After this, the candidate must pay a fee for each resubmission).
